Guidelines for applicants

APPLICATION DEADLINE: NOVEMBER 10, 2023 (applying is free of charge)

Filled-out online application form and links to applicant's project and previous work have to be submitted by November 10, 2023. Applications submitted after November 10, 2023 will not be considered.

Project selection assures participants with free accreditation to the industry sessions of the East Doc Platform, the festival screenings of One World festival and all networking events.

WHAT PROJECTS ARE WE LOOKING FOR?

Creative feature length documentary films (creative story/character-driven), factual series, and non-fiction interactive factual (XR/VR/AR, webdocs etc.) projects from Central and Eastern Europe ([see eligible the list of countries](#)) in development, production, postproduction stage, as well as finished short and feature¹ films. The selection is also open to the international productions with projects thematically bound to CEE region.

East Doc Forum: Pitching for Central and East European creative documentary projects in development or in production stage, including factual series. Participation includes five day-long pitch training and preparation, networking opportunities and individual meetings with invited decision makers.

East Doc Interactive: A three day-long workshop with consultations and networking opportunities for documentary projects with VR and interactive elements in development or in production.

East Doc Market: Pre-arranged one-on-one meetings with decision makers for documentary projects in production and post-production.

East Silver: Pre-arranged one-on-one meetings with decision makers for documentary projects in post-production, rough cut stage and finished films looking for festival distribution and available for world/international premiers.

- All requested materials submitted prior to the deadline
- English subtitles for all audiovisual materials

PROJECT SELECTION

The programme is open to projects from Central and Eastern Europe ([see eligible the list of countries](#)). Projects will be assessed by a committee made up of international experts and IDF staff. The list of 8 – 10 projects selected to attend the Forum will be announced in January 2024 at [dokweb.net](#).

CONDITIONS OF PARTICIPATION

The filmmaker teams (director and producer) have to attend both the East Doc Forum workshop and the pitching sessions (March 22 – 28, 2024). Team members have to be proficient in English. The East Doc Forum will only accept projects that have duly paid the participation fee and submitted all documents and information requested by the organizers prior to the event.

PARTICIPATION FEE

Successful applicants whose projects are selected have to pay the participation fee by January 31, 2024. The participation fee is 150 € (administration fee, covering two industry passes). Please note that the final amount will be concluded upon selection based on the attending team size and is used to cover accommodation and one meal per day per person. Travel expenses are paid by the participants. Projects that fail to pay the fee will be excluded from participation at the East Doc Forum workshop and pitching session.

PROJECT SELECTION

The East Doc Interactive is open to all kinds of interactive projects, XR, VR, AR projects, as well as interactive webdocs etc., covering any projects with an innovative approach to the story, idea execution or both: virtual reality, transmedia projects developing new storytelling, linear documentaries with interactive supporting projects, engaging online platforms, and multimedia. The projects can be at any stage of development, or production. Completed projects will not be accepted.

The program is open to interactive documentary projects from all over Europe ([see eligible the list of countries](#)), with preference given to projects from Central and Eastern Europe. East Doc Interactive will present up to five interactive projects. The list of 5 projects selected to pitch will be announced in January 2024 at dokweb.net.

CONDITIONS OF PARTICIPATION

The filmmaker teams (director and producer) must both attend the East Doc Interactive workshop and networking (March 26 – 28, 2024). Team members must be proficient in English. East Doc Interactive will only accept projects that have duly paid the participation fee and submitted all documents and information requested by the organizers prior to the event.

PARTICIPATION FEE

Successful applicants whose projects are selected have to pay the participation fee by January 31, 2024. The participation fee is 150 € (administration fee, covering two industry passes). Please note that the final amount will be concluded upon selection based on the attending team size and is used to cover accommodation and one meal per day per person. Travel expenses are paid by the participants. Projects that fail to pay the fee will be excluded from participation at the East Doc Interactive programme.

PROJECT SELECTION

Decision makers will receive a catalogue with selected projects prior to the event and will decide which projects are of their interest. Also, the list of decision makers will be available to the participants and they select up to 10 decision makers they would like to meet. The final list of meetings will be based on the preferences from both sides. Each meeting lasts for 15 minutes.

PARTICIPATION FEE

Successful applicants whose projects are selected have to pay the participation fee by January 31, 2024. The participation fee is 150 € (administration fee, covering two industry passes). CONDITIONS OF PARTICIPATION

Filmmakers selected for the East Silver will take part in pre-arranged individual meetings with international decision-makers, festival selectors and sales (**March 26, 2024**). Decision makers will receive a catalogue with selected projects prior to the event and will decide which projects are of their interest. Also, the list of decision makers will be available to the participants and they select up to 10 decision makers they would like to meet. The final list of meetings will be based on the preferences from both sides. Each meeting lasts for 15 minutes.

Team members have to be proficient in English. The East Silver will only accept projects that have duly paid the participation fee and submitted all documents and information requested by the organizers prior to the event.

PARTICIPATION FEE

Successful applicants whose projects are selected to East Silver and will take part of East Silver have to pay the participation fee by January 31, 2024. The participation fee is **75 €** (administration fee, covering two industry passes). Please note that the final amount will be concluded upon selection based on the attending team size and is used to cover accommodation and one meal per day per person. Travel expenses are paid by the participants. Projects that fail to pay the fee will be excluded from participation in the event.
